

TUITION AND FEES 2007-2008

ALL FEES ARE INCLUDED IN THE AMOUNT LISTED BELOW (Tuition, Book Fee, Playground Fee, Educational Media Services Fee)! The total amount due has been divided into 11 equal payments. One payment is due with registration by May 1. Another payment is due at August Packet Pick-Up. The remaining 9 payments will be spread over the months of September through May. If you would like, you may still pay the full amount at the beginning of the school year or pay by semester.

Standard Fees Eligibility Policy - Active parishioners who donate \$400.00 or more per year in their Sunday Envelope and do volunteer work for the parish pay the Scale A, the standard tuition rate, for parish services and activities. No one will be denied parish services or activities because of an inability to pay fees. Those who can not afford these fees may be eligible for assistance or reduction.

POLICIES FOR TUITION AND FEES

REGISTRATION FEE The registration form of 1 payment is due by May 1, 2007. A registration form and registration fee are required to hold a place within a specific class. The fee is non-refundable but applies to the tuition amount.

AUGUST PACKET FEE The second installment is payable on or before **packet release on August 15, 16, and 17, 2007.**

PAYMENT SCHEDULE Payments with the exception of the registration fee and the August packet fee will be handled in one of the following methods:

1. Monthly installment program as established by the parish. Payments would be through automatic deduction from your bank account (ACH) to St. Kilian beginning September 2007 through May 2008. Payments will be due on the 15th of each month.
2. Payment in full to the parish through the school or parish office before August 17, 2007.
3. Two payment plan. 50% of the balance due will be due on September 15, 2007 and the remaining balance due on January 15, 2008.
4. A late payment fee may be charged for payments not received within ten days of due date.

ADDITIONAL FEES

LATE REGISTRATION FEE \$50.00 per family. Assessed after May 1, 2007 to families registering for 2007-2008 who were registered in the 2006-2007 school year.

BAND FEE \$275.00 per child for the year. Applies only to fifth through eighth grade students in band. This fee covers lessons and band practices, not the rental cost of instruments. **This fee should be paid in full at the beginning of the school year or in two installments due at the beginning of each semester.**

ADDITIONAL REQUIREMENTS

\$CRIP PARENT PARTICIPATION PROGRAM All families are expected to participate in the \$crip Program purchasing enough \$crip to insure a \$100.00 profit. This means purchasing approximately \$2,500.00 worth of \$crip. Profits are tracked throughout the year. **Those families who have not reached the \$100 profit by March 31 will be billed for the difference. More information is available in your registration packet.**

PARENT INVOLVEMENT POINTS School parents must accumulate 500 points for two adult households and 250 points for single adult households through volunteer work within the school and parish. **Participation points must be completed by March 31.** Families are responsible for keeping track of their points and reporting these to the school office. Those families who have not fulfilled their point requirements will be billed \$1 per outstanding point. More information on the Parent Involvement Program is available at the school.

Tuition Assistance

No child will be denied the opportunity for a Catholic Education because of the inability to pay tuition. Tuition assistance programs are available by contacting the school principal or the Director of Administrative Services. Tuition assistance is based upon eligibility for free or reduced lunch.

PAST DUE TUITION DURING THE SCHOOL YEAR In the event that a family falls behind in monthly tuition payments during the school year we reserve the right to:

1. Contact family by letter and telephone to arrange payment.
2. Send a certified letter and assess late penalty fees.
3. Take any appropriate action the parish feels necessary. Additional fees up to double the amount owed will be assessed to cover the cost to the parish of any actions taken.

PAST DUE TUITION AT THE END OF THE FISCAL YEAR In the event that there is outstanding tuition due from previous school years by June 30, we reserve the right to:

1. Refuse future admission.
2. Withhold the transfer of school records.
3. Take any appropriate action the parish feels necessary. Additional fees up to double the amount owed will be assessed to cover the cost to the parish of any actions taken.
